

Community Campus, Parks and Recreation Waiver & Release of All Claims

Please read this form carefully and be aware that signing up and participating in ay FMI sponsored activity, signing up and renting any FMI facility, or using any recreational or other facilities provided by FMI, you will be waiving and releasing all claims for injuries you might sustain arising out of these actions.

Acknowledgement of Risk of Injury Clause

"As a participant in an FMI sponsored activity, renter of an FMI facility, or user of any recreational or other facility of FMI, I recognize and acknowledge that there are certain risks of physical injury and I agree to assume the full risk of any injuries, including death, damages or loss which I may sustain as a result of participating in any and all activities connected with or associated with participating in such sponsored activity or as a result of renting or using any and all facilities connected with or associated with the townsite."

Waiver of Claim for Injury Clause

"I agree to waive and relinquish all claims I may have as a result of participating in an FMI sponsored activity or renting or using an FMI facility against FMI, its subsidiaries and affiliates, and their officers, agents, servants and employees."

Release From Liability Clause

"I do hereby release and discharge FMI, its subsidiaries and affiliates, and their officers, agents, servants and employees from any and all claims resulting from injuries, including death, damages and losses sustained by me and arising out of, connected with, or in any way associated with the activities described herein."

Indemnity and Defense Clause

"I further agree to indemnify and hold harmless and defend FMI, its subsidiaries and affiliates, and their officers, agents and employees from any and all claims resulting from injuries, including death, damages and losses sustained by me and arising out of, connected with, or in any way associated with the activities described herein."

Photo Release

"I hereby authorize and give my consent to FMI to photograph/video my child or me, and without limitation, to use such photographs/video in connection with promoting/advertising the services, programs, and facilities of FMI, without consideration of any kind, including, but not limited to, the townsite sponsored social media site(s)."

I agree to follow the regulations and understand that failure to comply with the regulations may result in termination of my guest privileges. I understand the Bagdad Community Campus reserves the right to add or delete regulations at their discretion. I have read and fully understand the program details, waiver, and release of all claims.

While at the Bagdad Aquatic Center, courteous behavior is expected and appreciated. Unacceptable behavior may result in termination of privileges.

- Customers are responsible for securing their valuables. BAC/Community Campus is not responsible for lost or stolen items.
- Glass objects, pets and food/drinks are prohibited in and around the pool area with the exception of drinking water.
- No smoking, alcohol or chewing gum.
- Persons with open wounds, bandages, or any symptoms of a communicable disease must not enter the pool.
- No street clothes, cutoffs, inappropriate swimming attire.
- Feet first entries from pool edge only.
- No diving, running or horseplay.
- Children not toilet trained must wear swim diapers.
- Parents and guardians must watch their children.
- Children under 10 years old or non-swimmers REQUIRE a responsible adult (18 years or older) or a parent.
- Children 5 years old or younger and non-swimmers must be within arm's reach of a responsible adult (18 years or older) or a parent at all times.
- Lifeguards have complete authority in pool area.
- Campus waiver must be signed before entering pool area.

Swim Test Required

Ages 10-12 – determines if child can come without supervision

Ages 6-9 – determines if the child can swim in the deep end without parent/guardian

Ages 6-9 – still require a responsible adult (18 years or older) or parent when they come to the pool.

Please observe and comply with all pool rules.

Bagdad Fitness Center Rules and Regulations

All rules and regulations are set for your safety in mind. We thank you in advance for your cooperation Please bring any problems or questions to the attention of a staff member.

The Fitness Center attendants have the authority to enforce all rules and regulations. Persons that do not comply will be subject to:

- 1. Verbal Waring
- 2. Incident Report Write Up
- 3. Asked to leave the premises for the remainder of the day (parents contacted if under 18). If an individual refuses to leave, law enforcement will be called and a notice of trespass will be issued.
- 4. On-going issues, individuals will not be allowed back to the facility.
- Sign-in is required every visit
- Must have current waiver to use facility
- All equipment must be used as designed. Members will be held responsible for any damages to fitness center property.
- No loitering, smoking, chewing or alcohol on premises
- No food or beverage except for water in the workout area
- No glass containers in center
- No horseplay
- Shirts and shoes (no sandals or flip flops) must be worn at all times while in the fitness center
- Re-rack weight plates and dumb-bells when finished
- Do not drop the weights or bang them together unnecessarily
- If you bring in your own music, you may be asked to turn it down as not to disturb others
- Use of equipment is on a first come, first served basis, therefore please be considerate and limit your time on the equipment
- Please notify the attendant immediately of any equipment problems. Do not use equipment that is not working properly.
- For health and safety reasons, no one under the age of 14 is permitted in the fitness center. No exceptions.

Use of the facilities is considered a privilege and privileges can be revoked due to vandalism, misuse of equipment, or any form of disorderly conduct.
